

**TRIPLE O'S –20<sup>th</sup> ANNIVERSARY CONTEST**  
**("Contest")**

**RULES AND REGULATIONS**

CONTEST BROUGHT TO YOU BY WHITE SPOT LIMITED ("TRIPLE O'S"). NO PURCHASE NECESSARY. CONTEST IS VOID IN WHOLE OR PART WHERE PROHIBITED BY LAW. SEE ELIGIBILITY SECTION BELOW FOR FURTHER DETAILS. **(1) CONTEST PERIOD:**

The Contest will begin at 10:00 AM (Vancouver time) on September 10th , 2017 and end at 12:00 AM (Vancouver time) on September 29<sup>th</sup>, 2017 (the "Contest Period").

**(2) ELIGIBILITY:**

In order to be eligible to win a prize, an entrant must be a resident of British Columbia and must not be (and no member of his/her immediately family shall be) an employee of White Spot Limited or any affiliate of the foregoing. For the purposes of these Rules and Regulations, "immediate family" means husband, wife, spouse, mother, father, brother, sister, son and/or daughter, whether by blood, marriage or adoption and whether or not they reside in the same household.

White Spot Limited shall have the right at any time to require proof of identity and/or eligibility to participate in the Contest. Failure to provide such proof may result in disqualification. All personal and other information requested by and supplied to White Spot Limited for the purpose of the Contest must be truthful, complete, accurate and in no way misleading. White Spot Limited reserves the right to disqualify any entry or entrant in its sole discretion, should any entry or entrant at any stage contain and/or supply untruthful, incomplete, inaccurate or misleading personal details and/or information.

### **(3) HOW TO ENTER:**

No Purchase Necessary. To enter the Contest, please follow these steps:

- Complete entry form including name, Address, phone number, email address, city, province, postal code, phone number, skill testing question & submit in entry box.
- Alternatively: Complete and submit the contest online entry form.

There is a limit of one entry per person.

### **PRIZE DETAILS:**

There is one \$100 gift card prize available per participating Triple O's location throughout the contest period. For locations that do not redeem gift cards, the \$100 gift card prize will be given in Free Burger Combo Cards equivalent to a \$100 Triple O's Gift Card.

There is a single grand prize including the entirety of: 'FREE BURGERS FOR A YEAR' (\$1200 value), On-The-Go Truck catering for the winner/50 friends (up to \$1200 value) and \$1000 in Chevron gas to be won.

"FREE BURGERS FOR A YEAR" is awarded in 12 x \$100 Triple O's gift cards. Gift cards can be used at participating Triple O's locations (excluding: Rogers arena, PNE/Playland, Pacific Coliseum, BC Ferries, Langley Events Centre and River Rock Casino).

Gift cards can be used on single or multiple visits with any unused balance on the gift cards to be used upon subsequent visits within an unlimited time frame.

Location of On The Go Truck catering event is restricted to the Metro Vancouver area only and is based on the Triple O's truck availability (some blackout dates apply in the summer). Must be redeemed by December 31, 2018. No cash value.

Odds of being selected as the winner depend on the number of ballots received.

### **(5) WINNER SELECTION:**

\$100 gift card winners will be selected randomly by a White Spot Limited representative for each participating Triple O's location's ballot pool on October 15<sup>th</sup>, 2017 and will be contacted by 5pm Wednesday, October 15<sup>th</sup>, 2017 by phone or email.

The grand prize winner will be selected randomly by a White Spot Limited representative at 10am on Wednesday, October 15<sup>th</sup>, 2017, and will be contacted by 5pm Wednesday, October 15<sup>th</sup>, 2017 by phone or email.

The selected entrants (or the parent or legal guardian of the selected entrants, where the selected entrant is under the age of majority) must also agree to sign and return White Spot Limited standard Declaration and Release Form.

If any selected entrant does not meet all the Contest conditions, or does not reply within seven (7) days of the initial documented contact attempt by White Spot Limited, that entrant will be disqualified and White Spot Limited shall be entitled to select a new entrant from amongst the remaining eligible entries.
